

DISNEYLAND BASKET RAFFLE

RULES & REGULATIONS

ELIGIBILITY: Entry purchaser, and anyone to whom an entry purchaser legally transfers an entry, must be an individual 21 years or older at time of entry purchase. Entry purchaser must be present in the state of Arizona at the time of entry purchase. It is not necessary to be a resident of the state of Arizona, but one must be physically present in Arizona at the time of entry purchase. Only one (1) individual may be identified as an entry purchaser. All federal, state and local laws and regulations apply. Ticket entries can be purchased in the DWES front office. A hard copy ticket confirmation number is required to claim the Raffle prize. By entering the Disneyland Basket Raffle (the "Raffle"), the entry purchaser acknowledges that he or she is aware of, and agrees to abide by, the Raffle's rules and regulations.
